On January 29, 1992, the parties to this action entered into an agreement whereby they resolved the matters at issue in Unit Clarification No. 8-91 as follows:

1. The positions of Bus Aide, Crosswalk Guard, Title V Home-School Coordinator, Title V Indian Education Tutor, Volunteer Program Coordinator and Inventory Controller are included in the Billings Classified Employees Association (BCEA) unit.

2. The position of Even Start Advocate is included in the Billings Education Association (BEA) unit.

3. The position of Grant Writer shall be included in either the BEA or the BCEA unit. On or before February 7, 1992, the parties shall enter into a written agreement declaring in which unit the position of Grant Writer will be included. Upon execution

1 of that agreement, a copy shall be appended to this Order and
2 incorporated by reference as if fully set out here.

3 4. According to the District's representations, the
4 positions of Even Start Specialist and Broadcast Lab Technician no
5 longer exist. Therefore, neither is included in either the BEA or
6 the BCEA unit.

7 5. Based on the District's representations, the parties have
8 agreed that the position of Bus Manager is a supervisory one and
9 therefore, is not included in either the BEA or BCEA unit.

10 6. By agreement of the parties, Personnel Specialist I and
11 II, Payroll Specialist I and II, Attendance Officer, and
12 Administrative Specialist I and II are not included in either the
13 BEA or BCEA unit.

14 WHEREFORE, the parties having agreed to settle the matters at
15 issue in this case,

16 IT IS HEREBY ORDERED that the BEA and BCEA units shall be
17 modified as described above and

18 IT IS FURTHER ORDERED that Unit Clarification No. 8-91 shall
19 be and hereby and is dismissed.
