ORDER

24 Pursuant to ARM 24.26.630 et seq., Jeff J. Minkler, acting on behalf of public employer
25 Kalispell School District No. 5, filed a petition for unit clarification with this Board on October
26 8, 1999. Petitioner has satisfied all of the prerequisites of ARM 24.26.630 (1), therefore the
27 Petition is valid. Respondent has failed to file any timely response in accordance with ARM
28 24.26.630 (4).


29 Petitioner is requesting that a certain position with one incumbent, Payroll Clerk, now
30 within Respondent's bargaining unit be removed. The position has been assigned duties that
31 include assisting the District's labor relations consultant and Business Manager directly in
32 formulating management policies and handling confidential information relating to the District's
33 collective bargaining proposals and supporting data prior to transmission to affected labor
34 organizations. Based upon these duties, Petitioner contends that the Payroll Clerk position is a
35 true "confidential employee" as defined by section 39-31-103 (3), MCA and by numerous Board
36 of Personnel Appeals, NLRB and Supreme Court decisions under the "labor nexus" doctrine.
37 See E & L Transport Co., 160 LRRM 1115 (1998); Montana Education Association, NEA and
38 Missoula County High School and Montana Federation of Teachers, AFT, AFL-CIO, UD No. 7-
39 89 (1989); NLRB v. Hendricks County Rural Electric Corp., 454 U.S. 170, 189 [108 LRRM
40 3105] (1981); and Lewis and Clark County vs. Montana Public Employees Association, UC No.
41 4-79 (1979).

42 There being no argument made to the contrary of Petitioner's motion, no question of fact
43 exists under ARM 24.26.630 (5). Therefore, Petitioner is granted relief by this Board. The
44 position of Payroll Clerk, Kalispell School District No. 5 is a bonafide confidential employee
45 position under section 39-31-103 (3), MCA and is now removed from the above-mentioned
46 bargaining unit.
