24 I. INTRODUCTION

25
26 On January 16, 2002 the Montana Public Employees Association (Union) of Helena,
27
28 Montana, filed the instant petition requesting the Board clarify that positions #17013 and #17970
29
30 are part of the existing bargaining unit. The Department of Justice, Registrar's Bureau,
31
32 (Employer) filed its response on February 11, 2002, wherein the Employer stated it did not
33
34 contest the Union's petition.

37 II. DISCUSSION

39 The Union contends the two positions are compliance specialists in the dealer licensing
40
41 and compliance unit and the Employer agrees with this contention. In fact, the Employer
42
43 indicated in the letter of February 11, 2002, that it is in the process of making the necessary
44
45 changes on the position records to reflect the inclusion of positions #17013 and 17970 in the
46
47 bargaining unit and requested that the Union provide the incumbent employees with dues
48
49 authorization forms.

1 III. DETERMINATION

2
3 It is determined that no question of fact exists and that in fact the parties have stipulated
4
5 to a modification of the existing unit. Therefore, pursuant to ARM 24.26.630 (5)(a), consistent
6
7 with the agreement of the parties, the petition to include positions #17013 and #17970 in the
8
9 existing bargaining unit is hereby granted.
