RECOMMENDED
ORDER

25 On July 5, 2002, Lewis and Clark County - Health Department filed a petition with
26 this board seeking to exclude exempt supervisory employees from the Respondent's
27 collective bargaining unit. By letter dated July 19, 2002, the Respondent, Montana
28 Public Employees Association, agreed that three positions should be excluded for the
29 reasons stated in the petition: Clinic Coordinator position which is filled by Paula Block
30 and two Public Health Nurse III positions which are filled by Kay Robertson and Jeanne
31 Underhill. The Petitioner agreed that these are the positions in question and stipulated
32 that no other positions were in dispute.

34 Pursuant to ARM 24.26.630(5)(a) it is determined that no question of fact exists
35 and the parties have stipulated to a modification of the existing unit. This recommended
36 order grants the above-described modification consistent with the agreement of the
37 parties. The recommended order is subject to board review if appealed within 10
38 business days. If not appealed, the recommended order is the final board order.


