27 On March 3, 2004 the Board of Personnel Appeals received a petition for Unit  
28 Clarification from the Montana Department of Revenue, Liquor Warehouse and the  
29 Montana Department of Administration, State Personnel Division seeking to remove the  
30 position currently known as "floor boss" from the Respondent's bargaining unit. The  
31 Petitioner alleged that the position currently held by incumbent Mr. Bill Susag performed  
32 supervisory duties as identified in 39-31-103(11) MCA.

33 After reviewing the petition and supporting documentation, the Respondent  
34 Montana Public Employees Association stated by letter dated March 8, 2004 that it had  
35 no objection to the petition to remove position number 05208 from the bargaining unit.  
36 The description of the unit is hereby modified to recognize this exclusion.
