27 Since the above matters concern the same parties and modifications to existing
28 bargaining units it is recommended that the above unit clarification petition actions be
29 consolidated. Further, pursuant to agreement between the parties; there being no
30 question of fact; and, pursuant to ARM 24.26.630 (5) (a) it is further recommended that
31 the bargaining unit description of the bargaining units involving AFSCME Montana
32 Council 9 and the City of Red Lodge be modified as follows:
33

34 The position of police sergeant be deleted from the bargaining unit so that the amended
35 description is:
36

37 deputy clerk, equipment operators, water/sewer operators, street employees,
38 working foreman, water/sewer foreman, office workers, mechanic of the City of
39 Red Lodge excluding supervisors, confidential employees, members of other
40 bargaining units and those exclusions as defined by the code.
41

42 The position of police sergeant be added to the law enforcement bargaining unit so that
43 the amended description is:
44

45 all police officers and the police sergeant working for the City of Red Lodge
46 excluding supervisors, confidential employees, members of other bargaining
47 units and those exclusions as defined by the code.


