25 A petition was filed by the Glendive Federation of Teachers, MEA-MFT, NEA, AFT,  
26 requesting a clarification of a bargaining unit described in the collective bargaining  
27 agreement between the GFT and Dawson Community College as "faculty members in  
28 the bargaining unit as certified by the State of Montana Board of Personnel Appeals on  
29 May 7, 1975". The petition requested that the bargaining unit be clarified to include all  
30 head coaching positions including baseball, rodeo and golf.

32 The petition was duly served on Dawson Community College and the College had no  
33 objection to amending certification. There being no question of fact, and the parties  
34 agreeing to the requested clarification, it is recommended that Unit Clarification Petition  
35 # 2-2010 be granted and the bargaining unit clarified in accord with ARM 24.26.630 (5)  
36 (a) to include head coaching positions including baseball, rodeo and golf.
